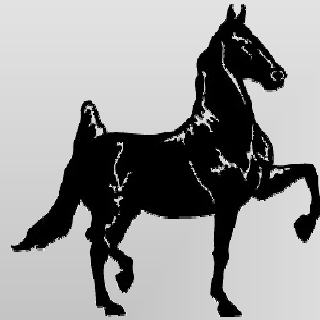

## USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

## Motorized Vehicles Statement

### In accordance with GR1301.7:

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

## Show Rules and Regulations

**EVERY CLASS** offered herein which is covered by the rules and specifications of the current U.S. Equestrian Federation rulebook will be conducted and judged in accordance therewith.

**THE HORSE SHOW EXECUTIVE COMMITTEE** reserves the right to itself interpret all questions and conditions in regard to, or arising out of, or incident to, the show, without claims for damages or recourse of any kind. Any questions not covered in these rules and regulations shall be decided by the Horse Show Committee; their decision is final. The Horse Show Executive Committee shall include the Competition Manager of the show, and the Horse Show Secretary.

**JUDGES:** The Summer Showcase Horse Show reserves the privilege of substituting or changing judges if it becomes necessary. The Judge's decisions in the show ring are their own responsibility and Show Committee accepts no responsibility for their decisions.

**SHOW SCHEDULE:** Management reserves the right to reschedule, combine or divide any class for the over-all good of the show. All exhibitors will be notified according to the USEF Rules.

**ENTRIES:** ONE OWNER PER ENTRY FORM. Entries must be made on an official entry form or photocopy and be signed by (1) exhibitor, (2) the rider, driver or handler and (3) the trainer or by the agents of such persons and must be accompanied by funds to cover entry fees, Association fees and Drug and Medication fee. In case of a rider, driver, or handler under 18, his/hr parent or guardian, or if not available, the trainer, must sign. Entries must contain complete address of rider, owner and trainer with USEF Membership Numbers or a \$30 Non-Member Registration Fee for each handler, rider, owner, lessee, agent or trainer. Entries must contain complete description of horse with USEF recording number (if recorded) and Breed Association Number if appropriate.

**ENTRY FEES & STALL RESERVATIONS** must be pre-paid by check or money order payable to Oregon Horse Center and mailed or sent overnight to: Oregon Horse Center c/o Heather Engstrom, Show Secretary, 90751 Prarie Road, Eugene Oregon 97402

**ENTRIES CLOSE AND MUST BE POSTMARKED BY JULY 9, 2010.**

**NUMBERS** will not be released to exhibitors by the Horse Show Office until all entry blanks are complete, all necessary copies of Registration papers, USEF membership cards and measurement cards or forms have been see, and all fees have been paid. EXHIBITORS MUST ALSO PROVIDE AN OPEN CHECK TO COVER ANY EXPENSES THAT MIGHT BE INCURRED BY THEM DURING THE COURSE OF THE SHOW. ALL ACCOUNTS MUST BE CLOSED BY EXHIBITORS IN THE SHOW OFFICE BEFORE END OF SHOW, OTHERWISE THE OFFICE WILL CLOSE ALL ACCOUNTS JULY 19TH AT A FEE OF \$25 PER CHECK.

**REFUNDS** will be given if written notice is received by the Show Secretary **before the closing of entries.** Exhibitors canceling their entries for any reason

after the official closing date shall forfeit all stall fees, unless a valid Veterinarian's or Doctor's certificate of disability for entered horse/rider is submitted to the Horse Show Secretary prior to the first event of the Horse Show, in which case a \$25 cancellation charge will be assessed and the balance of entry fees will be refunded.

**RV/OVERNIGHT PARKING** – Exhibitors may stay overnight in an RV, Trailer or Camper in the designated RV spaces, for a charge of \$15 to \$25 per night with electricity depending on the site, or \$10 per night without electricity. Spaces are pre assigned thru OHC office so check in when you get to the show for your spot. There are electrical hook-ups (limited water). **SHOW OFFICE FEE** – There will be a ONE-TIME fee of \$20 PER OWNER.

**SHOW OFFICE AND REGISTRATION** – Registration at the Horse Show Office by the exhibitor is required. The Horse Show Office will be open on Wednesday, July 14th at 9 A.M. & remain open until 7 P.M. During the show, office will be open from ½ hour before start of each session to ½ hour after each session ends.

**VETERINARIAN** – A veterinarian (Del Oeste (541) 689-0205) will be ON CALL and information will be posted at the show office. All animals are subject to physical inspection by the Show Veterinarian at the discretion of the Show Committees. The Show Management reserves the right to refuse entry onto the show grounds to any horse exposed to, or which may be harboring a communicable disease.

**STABLING ASSIGNMENTS** – It is recommended that exhibitors wishing to be stabled together note that on your entry form. Regular stalls with full doors are available for \$125 per stall for the entire weekend. Bedding is available at a cost of \$8 per bale. No straw allowed for bedding on the grounds. Each horse must be assigned to a separate stall (exception: broodmares with suckling foals). Horses must be placed in the stalls assigned. No changes will be permitted without express consent of the Secretary or Barn Manager. Early arrivals on Tues/Wed, and staying an extra day are *no charge*.

**CLEANING OF STALLS** – Manure dumping will be at the North and South corners of the show stall barn. Barrels are placed at the end of aisles for refuse. Deposit refuse directly in barrels provided. Do not mix manure and other refuse.

**SHOWING FROM TRAILERS** – Exhibitors may show from their trailers at the fee of \$25.00 PER HORSE PER DAY. Every horse is required to pay a stall fee, daily stall fee or a grounds/trailer in fee. Horses on the grounds overnight must be stalled.

**HAY & GRAIN** – H & E Feed is located ½ mile from the Center for any additional needs. Contact H & E Feed for preorders (541) 688-3214.

**SHOW AND WARM-UP ARENAS (3)** – There are three (3) arenas for your use. The main Silverado Show Arena is 285 x 116. The Logan Warm-Up Arena is 200 x 120, and the Emerald Warm-Up Arena is 200 x 100. Arenas are comprised of a mixture of native soil and sand.

Travel on I-5 to Eugene and take Beltline Exit 195 West. Travel West towards Junction City/Airport. After traveling approximately six miles West on Beltline, take the N.W. Expressway Exit 7b. Turn right at the stop sign. Proceed 2 miles North on N.W. Expressway to 90751. The Oregon Horse Center is on the right side of the road.

If coming from HWY 99, turn east on Awbrey Lane. Go approximately 1 mile to the end of Awbrey Lane. The Oregon Horse Center will be visible in front of you. Turn right and you will see the Oregon Horse Center entrance immediately on your left.

## Saddlebred Show Pleasure Section

Entries shall be shown with a full mane and tail. Horses showing in the Show Pleasure division may wear tailsets or bustles, but may not show with the tail gingered, tied or braced, and unset tails with not be penalized. The fact that a horse's tail has once been set does not exclude participation. Braids and inconspicuously applied hair in main and tail are permitted, Shoe bands and pads are permitted. Quarter boots are permitted only in Five Gaited classes. Cross entering at the same competition is prohibited between Show Pleasure and Country Pleasure. Cross entering between Three- and Five-Gaited classes at the same competition is prohibited. See USEF 2006 Subchapter SB-8

## Saddlebred Park Section

Entries must be shown in full main and tail. Horses can have set or natural tails. To be shown at an animated walk or flat walk, trot or canter. Horses to stand quietly. To be judged on performance, manners, presence, quality and confirmation. Horses shown in this division are ineligible to show in the Saddlebred Performance Division. (i.e., Three-Gaited, Five-Gaited, and Fine Harness) or the Saddlebred Pleasure Division at the same competition. See USEF 2006 Subchapter SB-9.

## Saddlebred Country Pleasure Section

Country Pleasure horses must be plain shod. Permissible as plain shod shall be a shoe (inclusive of caulks), which may be thicker at the heel and may include toe clips and side clips. Also permissible is an eggbar shoe. Not permissible as plain show: bands, bars, pads of any kind, wedges lead, springs, any attachment that extends below the bottom of the shoe, and any foreign substance not specified as permissible. The sole and entire frog of the foot must be visible. Quarter boots are permitted only in Five-Gaited classes. Entries must be shown with full main and tail. Tails must not be gingered or put in any device (i.e., tailset, bustle or brace) which alters their carriage while on the grounds. The fact that a horse's tail has once been set does not exclude participation. Braids and artificial manes are prohibited. Inconspicuously applied hair in the tail is permitted. Cross entering at the same competition is prohibited between Show Pleasure and Country Pleasure. Cross Entering between Three- and Five-Gaited classes at the same competition is prohibited. See USEF 20063 Subchapter SB-7
